**STALLION BREEDING AGREEMENT**

Stallion Owner will present a current-year service contract for inspection prior to the Stallion Service Auction. Breeding will sell under terms expressed in that contract, except when in contradiction with that of THE KENTUCKY QUARTER HORSE BREEDER'S ASSOCIATION. In that case, THE KENTUCKY QUARTER HORSE BREEDER'S ASSOCIATION contract will take precedence.

WITNESSETH:

In consideration of one dollar and other good and valuable consideration, we the owners of the stallion \_\_\_\_\_ registry number, \_\_\_\_\_ sell, transfer, and assign THE KENTUCKY QUARTER HORSE BREEDER'S ASSOCIATION Breeders' Futurity. A Breeding Service for the year 20 \_\_\_\_\_, to the above named stallion. It is expressly understood by all parties to this agreement that this Breeding Service is assignable only by THE KENTUCKY QUARTER HORSE BREEDER'S ASSOCIATION pursuant to the terms and conditions of its Annual Stallion Service Sale for the year in which said breeding applies, said terms and conditions being incorporated herein by direct reference thereto. All parties to this agreement are further bound and agree to all of the following terms and conditions:

1. That should the above stallion die or become unfit for breeding purposes and said mare has not been serviced by said stallion, then any moneys paid by mare owner to THE KENTUCKY QUARTER HORSE BREEDER'S ASSOCIATION shall upon proper verification of the above mentioned stallion owner, be given credit to purchase another stallion fee in the succeeding KENTUCKY QUARTER HORSE BREEDER'S ASSOCIATION Stallion Service Sale. If credit balance remains, credit will be issued for that balance the second year.
2. If a mare should die after the time she is first delivered to the stallion owner's premises for breeding, the mare owner will be entitled to a breeding for a replacement mare or a credit equal to the amount paid by the mare owner at the next stallion auction.
3. That stallion owner will not be responsible for any disease, accident, sickness and or death of mare or foal, and similarly mare owner will not be responsible for any disease, accident, sickness and or death of stallion.
4. A Breeder's Certificate shall be furnished mare owner upon payment in full, of all board and veterinarian expenses owed, and birth of live foal.
5. Breeding will sell under terms and conditions of current, breeding contract. THE KENTUCKY QUARTER HORSE BREEDER'S ASSOCIATION acts only as agent in this sale and will not be responsible for accident, sickness or death of any stallion, mare and/or colt.
6. The advertised breeding fee for this stallion for 20 \_\_\_\_\_ is \$ \_\_\_\_\_
7. The fee paid by mare owner for this stallion service as determined at 20 \_\_\_\_\_ KENTUCKY QUARTER HORSE BREEDER'S ASSOCIATION stallion service auction is \$ \_\_\_\_\_.
8. All stallion services not sold at auction are prorated as follows: 75% by February 1; 85% by March 1; 100% by March 2 or later.
9. Payment for said fee shall be made according to the following schedule:
  - A. 100% Date of auction
  - B. 50% Date of auction and 50% by May 1 or before mare leaves Stallion's Farm
  - C. Or when semen is received by mare owner
